You may pay your fine and court costs by mail or in person. In order to do so, you must plead guilty by signing the back of your copy of the ticket, and returning it along with a CERTIFIED CHECK OR MONEY ORDER payable to the Lebanon City Court. NO PERSONAL CHECKS WILL BE ACCEPTED.

You may be eligible to participate in the Court's traffic deferral program which would defer prosecution of your case. If you are interested, please contact the Court for further information. The following offenses do not qualify: CDL Drivers, Seat Belt Violations, Failure to Yield Emergency Vehicle, Failure to Yield Blue Lights, DWS, Driving Without Insurance, Anything Involving Drugs, Paraphernalia or Alcohol, Truck Logs Not Current, Radars, Failure to Obey Officer and/or Parking in Handicap/Fire Lane.

If you intend to plead guilty and pay the fine and court costs by mail, you must do so before the Court Appearance date noted on your ticket. If the fine and costs are not paid, you must appear in Court on the date set. Failure to pay or appear may result in a late fee or suspension. Court costs MUST be paid whether you appear in court or not. DO NOT contact the City Clerk or Mayor's office regarding your ticket.
